Committee Reports

Highway

Crew was out 28 times to plow. The 3-foot snow storm on the 17th may be able to be reimbursed through FEMA. Rodney submitted preliminary numbers through Otsego County for around \$24,000 The Christmas Day snow caused the berm of the road to collapse on Buckhorn Lake. The project has been completed with no funding available.

Agreement for The Expenditure of Highway Monies (Highway Law, Section 284) This agreement is required by New York State to allow Rodney to use money out of the DB fund which is \$180,000 for road repairs and the allocation of CHIP Funds of \$214,666. Rodney said the CHIPS dollar amount could change depending on what the State does.

- 1. GENERAL REPAIRS. The sum of \$180,000.00 shall be set aside to be expended for primary work and general repairs upon 59.38 miles of Town highways. The total sum of \$180,000 shall be set aside and not exceeded unless this agreement is amended by the Town Board and the Highway Superintendent.
- 2. PERMANENT IMPROVEMENTS. (CHIPS) the following sums shall be set aside to be expended for permanent improvements on Town Highways. A total sum of \$214,666.00 shall be set aside and not exceeded unless this agreement is amended by the Town Board and the Highway Superintendent.

It is agreed that all guidelines and sections as set forth by the New York State Department of Transportation, The New York State Highway Law, and the New York State Town Law will be adhered to and subjected to by the undersigned. It is further agreed the Town Highway Superintendent will complete and submit in a timely manner all state aid forms and required information to the appropriate agency.

Comments from Rich Cunningham of THOMA

Rich explained the process they have taken up to this point for the CDBG Grant. Applicants are based on lowest income and the need for repairs on their homes Homeowners than pick (3) three contractors that are ask for bids on each project, and then the determination is usually based on lowest bid. A letter goes out to contractor with letter to proceed. Once contractor has submitted his bill it will come to the Town for Approval. New York State will then wire money for the Town to pay contractor. Rich said that they have already done all of the eligibility requirements such as going out and inspecting the properties, making sure applicants are eligible and have finished with all of the bid work. Now they are asking for the Boards final approval.
