Tot Finder Decals for Fire Department

This information will be strictly confidential to the fire department only. This is to help aide the firemen responding to a house fire. They have asked the Town if they would be willing to contribute the cost of Tot Finder Stickers that will be given out at the school and handed out during carnival of sales. Again, this will help locate children's bedrooms in case of an emergency or fire.
