## Highway

Highway Superintendent, Rodney Renwick, discussed recent NYMIR Insurance walk-through. They were somewhat forgiving for the town office due to recent accident. They stated that we are doing things right with our highway trucks with using kill switches, etc. They suggested equipment rotations be less than 10 years. They were very impressed with our signage and inventory and how up to date we are with them.

The 10-wheel truck we ordered in February, 2022, is in production and should be at up-fitters by end of month. He is hoping to have it between June-August.

Another town may submit an offer on our 2016 10-wheel truck. Deputy Town Supervisor Jessica Grow asked if we could sell it before the new one arrives. Superintendent Renwick did not see any issues with that. He has requested that they submit their offers in writing.

Snow and ice were done 43 times to-date. They are 90% done with road sweeping. The spring cleanup is going well and will be done shortly. Winter was difficult on the roads but our roads faired good. Shoulder and ditching were done yesterday. Paving is scheduled for mid-May.

The driveway by the highway department has been worked on. They did shared service with Otego with using their excavator.

The tire/cleanup day will be 4/17 and 4/18. The highway staff will man it and the Village will transport.

Superintendent Renwick asked about surplusing the 1994 Ford 7740 tractor. If approved to do so, he'd like to try Frank Walker here in Unadilla to auction it. He specializes in farm equipment. It is of no use to us at this point.

Deputy Town Supervisor Jessica Grow made the motion to declare the 1994 Ford 7740 Tractor surplus. The motion was seconded by Councilman Donald Cole and unanimously carried. Roll Call; 3 Ayes, 0 Noes.
